My name is Camille Kaynor and I'm the Development Manager for the North Seneca Solar Project, an up to 90MW solar energy facility located in the townships of Junius and Waterloo. You can see detailed project information on our project's website: <u>https://www.northsenecasolarproject.com/</u>. Please note that this project is also located within the Waterloo Central School District.

Over the past year and a half, we have been conducting site acquisition efforts, environmental due diligence, and stakeholder/public consultations in preparation for submission of our state-level permit (via Section 94-c) application filing to the State's Office of Renewable Energy Siting (ORES).

Apart from the many environmental benefits associated with this project being a renewable energy facility, this project would also increase tax revenues to both the Towns and Waterloo Central School District. Additionally, as the project does not require permanent employees for its operation, North Seneca Solar Project would not create additional strain or burden on the School District or other public infrastructure.

I would also like to note that we have been in contact with the School District's Transportation Supervisor to understand the current bus routes so we can avoid and/or mitigate any transportation impacts during the construction period. Our transportation study is ongoing and will be included in our overall Section 94-c permit application to ORES.

Hi Camille,

I have reviewed the site safety and emergency response plans and they both seem to outline the correct notification procedures we would expect to see for initially reporting and responding to any emergency on site. I do have a few other questions/comments in thinking through the site layout:

1. Do you have more up to date project site layout map? The last one we have was from mid summer last year. We would like to see more detail regarding access points form roadways and where some of the maintenance buildings and sub stations might be located. Yes – please see attached for an up-to-date and more in-depth map. Please note that certain elements may change in the future as we continue the design and development process.

2. Can you provide estimates about how many personnel might be onsite both during construction and after final completion on a daily basis? During construction, there will be approximately 150 people onsite. During operations, there will only be 1-2 people onsite (on an intermittent basis for site maintenance).

3. As we might have mentioned before, one of our biggest concerns about the site would be any larger scale fires. Most of these site areas are significate distances off of paved roadways and great distances from hydrants. Although rare, these instances would require us to haul larger amounts of water into these areas with tankers. These apparatus can sometimes be over 30 feet in length and weighing over 50,000lbs with large turning radii. We like to suggest that these factors be taken into consideration for internal roadway structures and widths. I very much appreciate the note here. Our engineering team has confirmed that they have accounted for the size and weight of this type of apparatus in their design of all roadways.

4. In regard to site access, almost all of the fire departments in Seneca county have what is known as a knox box system. Local businesses provide access keys to all locked locations onsite and put them in this knox box which is normally mounted outside of the building or gated area. Each FD then has their own master key to access this box. The issue here is that each FD has their own special master key for the boxes in their respected jurisdictions. This would be something we would have to work out with the project team and Border City fire for example as we might both need access to the facility as the project is in both jurisdictions. We have run into this on another solar project – we would most likely attach multiple padlocks for the various FDs (see example image attached). Let me know if you think this could be a workable solution.

5. Providing any onsite radio frequencies to 911 and local fire departments is a great idea!! The local outlet mall does something similar with us and it is a great way to communicate with them. Happy to hear this feedback!

Let me know you thoughts and we can certainly discuss further at our upcoming meeting on 2/12.


